## EPA Lead Certification Safety Course for Renovation, Repair & Painting (RRP)

**Effective April 22, 2010:** New HUD & EPA regulations now require all contractors that disturb specified areas of lead-based paint in homes, schools and child care facilities built before 1978 to be certified and follow detailed, specific work practices to prevent lead contamination. **ARE YOU COMPLIANT?** EPA Lead Certification is now required for all residential remodelers and renovators, window installers, kitchen installers, drywallers, landlords, garage door installers, trim carpenters, painters, siding contractors, gutter installers, builders, plumbers, electricians, HVAC contractors ... and any other construction industry or maintenance professional working within residential, school and child care dwellings on projects that disturb lead paint in the environment.

- To be compliant with the new law, the certified individual must be on-site or accessible by phone at all times during the project.
- Companies also need to apply to be registered with the EPA to perform work under the new regulations by filling out a downloadable application at EPA.gov and paying a separate \$300 fee to the US Environmental Protection Agency. Non-compliant contractors may be liable for civil penalties of up to \$32,500 for each violation. Contractors who knowingly or willingly violate this law may be subject to up to an additional \$32,500 per violation, imprisonment, or both.
